The International Organization of Supreme Audit Institutions (INTOSAI) is a global body that supports its members in contributing effectively to the accountability of the public sector, in promoting transparency and good governance and in fostering the economy, effectiveness and efficiency of government's actions for the benefit of the citizens.

Under the motto "Mutual experience benefits all", INTOSAI has committed itself to responding to the needs and concerns of each member, to safeguarding and promoting a free and comprehensive flow of information and experience as well as to bundling the global audit-related knowledge and know-how.

It sets out INTOSAI's main priorities, like the support of SAIs' independence as well as their contribution to the achievement of the UN Sustainable Development Goals and the provision of high-quality standards.

INTOSAI's aims and purpose

INTOSAI is an autonomous, independent, professional, non-political organization established to:

- provide mutual support;
- foster the exchange of ideas, knowledge, and experiences;
- act as a recognized voice of SAIs within the international community;
- provide high quality auditing standards for the public sector;
- promote good governance; and
- foster SAI capacity development.

INTOSAI's main tasks

INTOSAI has four key strategic goals that focus on:

1. professional standards for the public audit profession;
2. capacity development of SAIs;
3. knowledge sharing and services for SAIs; and
4. good governance of INTOSAI.

INTOSAI's strategic priorities

In line with its Strategic Plan 2023–2028, INTOSAI focuses on the following five key priorities:

1. advocate for and support SAI independence;
2. contribute to the achievement of the UN 2030 Agenda for Sustainable Development;
3. support the development of SAI resilience;
4. promote and support equality and inclusiveness; and
5. enhance strategic partnerships.

INTOSAI's special focus areas

Supporting the independence of SAIs:

INTOSAI strongly advocates for strengthening the independence of SAIs.

The "IDI Global SAI Stocktaking Report 2020" identified troubling findings related to SAI independence.

INTOSAI aims to foster the independence of SAIs through raising awareness and through concrete mechanisms, like the "SAI Independence Rapid Advocacy Mechanism" (SIRAM) developed by the INTOSAI Development Initiative (IDI).


Contributing to the follow-up and review of the SDGs:

By reviewing and monitoring the implementation of the SDGs through their national governments, SAIs can essentially contribute to the achievement of the UN 2030 Agenda. In this regard, INTOSAI has been closely cooperating with the UN already for several years.



Setting professional standards:

INTOSAI supports the effective work and functioning of SAIs by providing and advocating for internationally recognized professional principles, standards and guidance. Through its Framework of Professional Pronouncements (IFPP), INTOSAI promotes the quality, excellence, credibility, independence, and relevance of public audits.



INTOSAI's main bodies

International Congress of Supreme Audit Institutions (INCOSAI)

The INTOSAI Congress is the supreme organ of the organization. It meets every three years and consists of all INTOSAI members.

In the framework of the INCOSAI, the most essential decisions on fundamental INTOSAI matters, like possible amendments of the Statutes, the Strategic Plan or the triennial budget are being taken.

Governing Board

The Governing Board meets annually to provide strategic leadership, stewardship, and continuity during and between Congresses.

The Chairman of the Board is the head of the SAI that hosted the last Congress.

General Secretariat


Located in Vienna at the Austrian Court of Audit, the General Secretariat provides strategic and central administrative support to INTOSAI.

By virtue of their office, the President of the Austrian Court of Audit is the Secretary General of INTOSAI.

The General Secretariat manages INTOSAI's finances, monitors compliance with its handbooks and regulations, maintains the member database, and hosts the INTOSAI website www.intosai.org.
